### **THIS POSITION IS OUTSIDE THE COMPETITIVE CIVIL SERVICE**

Appointment to this position will be made under the Excepted Authority of the NSF Act. Candidates who do not have civil service status or reinstatement eligibility will not obtain civil service status if selected. Candidates currently in the competitive service will be required to waive competitive civil service rights if selected. Usual civil service benefits (retirement, health benefits, life insurance) are applicable for appointments of more than one year. Disabled veterans with 30% service-connected disabilities as well as other applicants with severe disabilities will be considered without regard to the closing date if applications are received prior to final selection.

**DUTIES AND RESPONSIBILITIES:** This position serves as a Survey Analyst in the Division of Science Resources Statistics (SRS). SRS has as its prime objective the development of factual and analytical information on science and engineering resources. This includes data collections, surveys, and special studies on the education of scientists and engineers, the scientific and engineering workforce, and the financial and physical resources related to the U.S. research and development enterprise. SRS accomplishes its work using both in-house staff and contractors for data collections, surveys, methodological development, data dissemination and analytical activities.

The duties of this Survey Analyst position include the following:

- Performs detailed analyses of survey and other data and prepares analytical reports and data releases for the public; products must be on schedule and within budget. Takes into account the operational and technical aspects of a survey, including sample design, questionnaire design, statistical imputation, and data quality in the analysis and preparation of reports.
- Uses sophisticated techniques from statistics and/or social science disciplines to design and conduct analyses of complex national surveys.
- Uses knowledge of research methods, statistics, and survey methodology to evaluate the quality and suitability for use in analysis of data from outside sources.
- Conducts extensive outreach activities, including interactions with education and workforce researchers and other data users/customers to present survey findings and analysis and to learn what issues/topics are of interest to users as possible subjects for future reports.
- Works as part of a team to accomplish survey analyses and to develop the resulting reports and web products.
- Develops contracts and interagency funding agreements as needed to achieve desired objective of assigned survey analysis.
- Manages projects after award and serves as Contracting Officer's Technical Representative assuring that project objectives are met and quality standards are maintained within the project schedule and budget.

**QUALIFICATIONS REQUIRED:** Applicants must have a Ph.D. or equivalent experience in an appropriate field such as social science, statistics, or economics plus four or more years of successful research, research administration, and/or managerial experience pertinent to the position.

**QUALITY RANKING FACTORS:**

1. Ability to analyze data from large, complex national surveys for publication in statistical or analytical reports or for release in on-line databases.
2. Ability to take data gathered from multiple sources and evaluate, tabulate, analyze and disseminate those data in a coherent fashion in a variety of formats.
3. Ability to use advanced research and statistical methods to plan, conduct or direct analyses of complex survey data.
4. Experience working collaboratively within a team to conduct a research or analysis project or to produce an analytic report.
5. Ability to use oral and written communication skills to translate technical statistical material in language understandable to the public.
6. Ability to develop and maintain time schedules, project management systems, and financial and budget information for data analysis and related projects.

**BASIS FOR RATING:** Final ranking is based on an evaluation of your experience, education and training as they relate to the knowledge, skills and abilities specified in the Quality Ranking Factors. Current performance appraisal, letter(s) of recommendation, and awards may also be used in the evaluation process.

**CONDITIONS OF EMPLOYMENT:** Appointment to the position is contingent upon successful completion of the appropriate background investigation. Satisfactory completion of a one-year trial period may also be required.
