If the Offeror/Quoter cannot certify to the above, but can provide with their proposal or quotation information/documentation to show that an agency has considered suspension or debarment of the Corporation and has made a determination that this further action is not necessary to protect the interests of the Government, then the Offeror/Quoter (if a Corporation) may be further considered for award.

The contractor's inability or unwillingness to certify to 1) above or provide the information described in b. above shall render the contractor's quote or proposal ineligible for award.
