

REVISION OF THE NATIONAL SCIENCE FOUNDATION (NSF) COOPERATIVE AGREEMENT MODIFICATIONS AND SUPPLEMENTAL FINANCIAL & ADMINISTRATIVE TERMS AND CONDITIONS FOR MAJOR MULTI-USER RESEARCH FACILITY PROJECTS AND FEDERALLY FUNDED RESEARCH AND DEVELOPMENT CENTERS

EFFECTIVE OCTOBER 5, 2020

Unless otherwise specified in a special award condition of the cooperative agreement, or as modified below, the <u>Cooperative Agreement Financial & Administrative Terms and Conditions</u> (CA-FATC) dated October 5, 2020 are applicable to this cooperative agreement or cooperative support agreement. When the Modifications and Supplemental Financial & Administrative Terms and Conditions for Major Multi-User Research Facility Projects and Federally Funded Research and Development Centers or an award notice reference a particular section of the <u>Major Facilities Guide</u>, then that section becomes part of the award requirements through incorporation by reference.

Significant Changes

- **Equipment, Article 6.** This article has been revised to remove the exempt property consideration and is consistent with 2 CFR § 200.313 and 2 CFR § 200.316.
- Acknowledgement, Article 28. Requirements for naming and renaming NSF facilities have been added to this term.
- Foreign Collaboration Considerations, Article 57. Requirements related to foreign collaborations have been added to these terms.
- **Federally-owned Property, Article 63.** The name of the article has been changed from "NSF Owned Equipment and Real Property" to "Federally-owned Property". Additionally, requirements related to reporting Federally-owned property have been added to these terms.
- **Recipient-titled Property, Article 64.** Requirements related to reporting Recipient-titled property in the final inventory report and *ad hoc* reporting have been added to these terms.
- **Energy Conservation**, **formally Article 73**. Requirements related to energy conservation have been removed from these terms.
- **Knowledge Management, Article 77.** Requirements related to participation in NSF's Knowledge Management Program have been added to these terms.
- **Project Personnel and Competencies, Article 78.** Requirements related to Major Facility staff possessing professional competencies have been added to these terms.

Clarifications and Other Changes

- **Overall Document.** References have been updated to ensure consistency with the October 5, 2020 version of the CA-FATC.
- Liability, Article 55. Clarifies when an approved deductible will be reimbursed.
- **Contract Requirements, Article 61.** Clarifies notification to proceed to include NSF review of proposed activities and estimated costs.
- Financial Statement Disclosure of Federally-owned Property, Article 65. References to a \$70 Million dollar threshold have been removed and now the awardee must disclose the total book value of all individual designated Federally-owned property.
- **Motor Vehicle Management, Article 5 (FFRDC Section).** Clarifies the requirements to apply only when any motor vehicles are designated as Federally-owned property.
