BASIS FOR REVISING NSB AND COMMITTEE MEETING AGENDAS FOR NOVEMBER 8-9, 2016 ON SHORT NOTICE

On November 2, 2016 the Executive Committee of the National Science Board voted to make certain changes to the NSB and Committee agendas in the meetings scheduled for Tuesday, November 8 and Wednesday, November 9, 2016 EDT on short notice. After reviewing written material and receiving input from Board and NSF leadership, the Board Chair decided the Board's business is better promoted by addressing structural issues early in the meeting and deferring certain other topics. All NSB Executive Committee members, Drs. Córdova, Zuber, Souvaine, Jackson and Peterson, agreed that agency business requires these revisions.

The following meetings have revised agendas:

- 1) National Science Board in plenary sessions on November 8 and 9, 2016. The discussion of NSB Structure will be moved to the open plenary meeting on November 8 from the one on November 9.
- (2) Committee on Strategy and Budget's Subcommittee on Facilities (SCF) meeting on November 8, 2016. SCF will not meet separately. Its agenda items will be considered by the joint meeting of SCF and the Committee on Programs and Plans (CPP).
- (3) joint meeting of SCF and CPP on November 8, 2016. The agenda item relating to Facilities Roles and Responsibilities will be deleted. As noted, the SCF agenda items will be added to this meeting.

Other meetings on November 8, 2016, have modified beginning and ending times, but no agenda changes. The plenary Board meeting (open) on November 9, 2016, has modified beginning and ending times.

For the executive closed meeting of the Board, only the NSF Deputy Director, Board Executive Officer, Board Counsel, and Executive Secretary may attend. The Board Chair or Committee Chair may allow other necessary or appropriate attendees or restrict attendance further.
