

Background: America COMPETES Act of 2007

SEC. 7009. RESPONSIBLE CONDUCT OF RESEARCH



NSF's Policy Response to the America COMPETES Act



Proposal and Award Policies and Procedures Guide (PAPPG)

The Authorized Organizational Representative (AOR) is required to **complete a certification** that the institution has **a plan to provide appropriate training and oversight in the responsible and ethical conduct** of research to undergraduates, graduate students, and postdoctoral researchers who will be supported by NSF to conduct research.
