## **Submitting a Full Proposal**

After consulting with UEFISCDI, NSF will communicate the decision about the EOI to the proposers via e-mail. If NSF and UEFISCDI have not approved the EOI prior to the submission of a full proposal, the proposal will not be considered for evaluation (i.e., it will be returned without review).

If the EOI is approved, the proposers will be welcomed to submit a full research proposal to NSF. The proposal must be submitted by the established NSF program deadlines or target dates, where applicable. It is expected that full proposals will be submitted within 12 months of EOI approval. In the case of the original EOI expiring, proposers should send an e-mail to [nsf-uefiscdi@nsf.gov](mailto:nsf-uefiscdi@nsf.gov) for clarification on how to proceed, as a new EOI may be necessary.

## **Data Sharing**
